Privacy Policy

SMC Insurance Brokers Pvt. Ltd. ("us", "we", or "our") operates the website <u>kiasafety.com</u>, hosting MISP Insurance Application, (the "Service").

This page informs you of our policies regarding the collection, use, and disclosure of personal data, including that of customers solicited by you, when you use our Service and the choices you have associated with that data.

We use your data and that of customers solicited in the sale of motor insurance, to provide and improve the Service. By using the Service, you agree to the collection and use of information in accordance with this policy. Unless otherwise defined in this Privacy Policy, terms used in this Privacy Policy have the same meanings as in our Terms and Conditions.

This Privacy Policy is an electronic record in the form of an electronic contract formed under the Information Technology Act, 2000 and the rules made thereunder and the amended provisions pertaining to electronic documents/ records in various statutes as amended by the Information Technology Act, 2000. Information Collection And Use

We collect several different types of information for various purposes to provide and improve our Service to you.

Types of Data Collected

Personal Data

In other words, any information from which an individual can be identified.

Usage Data

We may also collect information that your browser sends whenever you visit our Service ("Usage Data").

This Usage Data may include information such as your computer's Internet Protocol address (e.g. IP address), browser type, browser version, the pages of our Service that you visit, the time and date of your visit, the time spent on those pages, unique device identifiers and other diagnostic data.

We will take all steps reasonably necessary to ensure that your data, including that of customers solicited by you as MISP, is treated securely and in accordance with this Privacy Policy and no transfer of your Personal Data, including that of customers solicited in the capacity of MISP, will take place to an organization or a country unless there are adequate controls in place including the security of your data and other personal information.

Disclosure Of Data

Legal Requirements

We may disclose your Personal Data and that of the customers solicited in your capacity of MISP, in the good faith belief that such action is necessary to:
